Summary: By signing this Participant Waiver and Release of Negligence Claims ("Release"), you are giving up substantial rights in exchange for the opportunity to participate in National Interscholastic Cycling Association ("NICA") programming, mountain bike races and other events conducted in Australia by Trek Australia Limited in cooperation with NICA (collectively, the "Events"). In particular, you agree <u>not to sue</u> Trek Bicycle Corporation (Australia) Pty Ltd. (CAN 143 457 998), Trek Bicycle Corporation, NICA, and each of their respective officers, directors, employees, representatives, volunteers, agents, advocates, affiliates, and all persons or entities providing goods and services (the "Released Parties") for any of their alleged negligence in connection with the Events. You are assuming responsibility for any injuries or damages you may sustain arising from your participation in the Events, as further detailed below.

1. Acknowledgement of Responsibility for Safety. This Release will prevent you, as well as your spouse, heirs, successors, assigns, and legal representatives, from suing any of the Released Parties for causing your injuries or damages, including where such injuries or damages are caused or contributed to through the negligence of the Released Parties.
